Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.parkerspawsllc.com, and Parker's Paws, LLC ® and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Parker's Paws, LLC ® include www.parkerspawsllc.com, Parker's Paws, House of Paws and www.parkerspawsllc.com. The Parker's Paws website is a booking site for grooming, boarding, purchasing of dog apparel and/or purchase of a new pet site. By using the Parker's Paws website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Parker's Paws may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Parker's Paws's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Sharing Information with Third Parties

Parker's Paws does not sell, rent or lease its customer lists to third parties.

Parker's Paws may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are

prohibited from using your personal information except to provide these services to Parker's Paws, and they are required to maintain the confidentiality of your information.

Use of Cookies
